TITLE: Approximately 70,000 gallons of Unleaded Mid-Grade Gasoline without Ethanol Approximately 40,000 Gallons of Diesel Fuel for Clinch Marina

Unleaded Gasoline: Approximately 70,000 gallons of unleaded mid-grade gasoline without ethanol with a minimum octane rating of at least 89.0 as required by Clinch Marina during the 2024 boating season. Delivered on a "Keep-Full" basis to an 8,000 gallon tank, to include a fuel protective lead substitute/conditioner (required). Conditioner must be bulk loaded as gasoline deliveries are made. Specify brand of conditioner. Early morning deliveries are a must.

Diesel Fuel: Approx. 40,000 gallons of dyed Diesel fuel as required by Clinch Marina during the 2024 boating season delivered on a "Keep-Full" basis to a 4,000-gallon tank. Early morning deliveries are a must.

Having carefully examined the attached specifications and any other applicable information, the undersigned proposes to furnish all items necessary for and reasonably incidental to the proper completion of this bid. Bidder submits this bid and agrees to meet or exceed all requirements and specifications unless otherwise indicated in writing and attached hereto.

Bidder certifies that as of the date of this bid the Company or he/she is not in arrears to the City of Traverse City for debt or contract and is in no way a defaulter as provided in Section 152, Chapter XVI of the Charter of the City of Traverse City.

Bidder understands and agrees, if selected as the successful Bidder, to accept a purchase/service order and to provide proof of the required insurance.

The Bidder shall comply with all applicable federal, state, local and building codes, laws, rules and regulations and obtain any required permits for this work.

The Bidder certifies that it is in compliance with the City's Nondiscrimination Policy as set forth in Administrative Order No. 47 and Chapter 605 of the City's Codified Ordinances.

The Bidder certifies that none of the following circumstances have occurred with respect to the Bidder, an officer of the Bidder, or an owner of a 25% or more share in the Bidder's business, within 3 years prior to the bid:

(a) conviction of a criminal offense incident to the application for or performance of a contract;

Bidder understands that the City reserves the right to accept any or all bids in whole or part and to waive irregularities in any bid in the best interest of the City. The bid will be evaluated and awarded on the basis of the best value to the City. The criteria used by the City may include, but will not be limited to: ability, qualifications, timeframe, experience, price, type and amount of equipment, accessories, options, insurance, permits, licenses, other pertinent factors and overall capability to meet the needs of the City. The City is sales tax exempt – Government.

Bidder must state their margin above rack price. Bidder must list branded price or unbranded price gasoline.

Rack price must be from a "major" petroleum supplier, and not a rack price from another jobber. "Major" supplier is deemed any company other than another jobber. In other words, this gasoline cannot be subcontracted out.

Bidder must provide a photocopy of their purchase invoice along with their billable invoice on each delivery so the City can check profit margin on each delivery in accordance with bid price.

Invoices: All invoices shall identify separately the gallons of gasoline, lead substitute, federal excise tax, Michigan gasoline tax, Michigan UST tax, Michigan prepaid sales tax, Michigan gas tax exemption.

Unleaded Gasoline: Approximately 70,000 gallons of unleaded mid-grade gasoline without ethanol.
